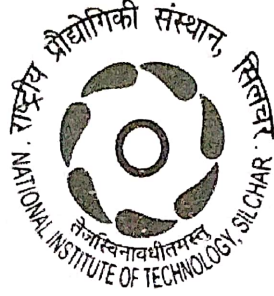

I. PREAMBLE

The Institution, **National Institute of Technology, Silchar (NITS)**, is one of the premier technical institutes of India and was established in 1967 as a Regional Engineering College in Assam. In 2002 it was upgraded to the status of National Institute of Technology and was declared as Institute of National Importance under the National Institutes of Technology Act 2007. The Institute has secured 7th Position among NITs and 38th place in the category of Engineering in NIRF-2022. NIT Silchar has secured 76th place in the overall category in NIRF - 2022.

Established in 1946, Karimganj College is one of the pioneering Colleges of Assam, imparting education in Science, Arts & Commerce. Situated on the bank of Kushiara River demarcating the Indo- Bangladesh Border, the College has played a significant role for the last seven decades in the field of Higher Education of the region. Today, it is one of the leading colleges under Assam University. The college has been reaccredited with 'B' grade with CGPA 2.78 in 4.0 point scale by NAAC in the year 2010.

National Institute of Technology (NIT) and Karimganj College here in after collectively referred to as institutions and individually as the institute formally agrees on a Memorandum of Understanding (MoU) as follows:

The Director of National Institute of Technology, Silchar and the Principal of Karimganj College, Karimganj for the purpose of furnishing cooperation in education and R&D activities between these two institutions, hereby affirm their intent to promote such academic and research collaborations and to participate in various academic endeavors.

2. OBJECTIVE

This MoU envisages the fulfilling of the following objectives:

- i. NITS will facilitate internship/training of Karimganj College students in domain Physics, Chemistry, Mathematics, Management and Environmental Science.
- ii. Karimganj College and NITS shall facilitate sharing of their laboratories facilities, library and materials including proprietary software of the Institutions and other in house developed components with each other as per mutually agreed terms and conditions. The aforesaid sharing shall be subject to terms of the third-party contract, if any, and shall be for the research purpose only.
- iii. Karimganj College and NITS shall exchange ideas and manpower with a view to enhancing mutually beneficial R&D activities, which would have a bearing on addressing national issues and problems.
- iv. Karimganj College and NITS shall explore the possibility of conducting joint seminars / workshops/ conferences at National and international levels, in areas of mutual interest.
- v. The faculties of Karimganj College and NITS shall be allowed to supervise students jointly i.e. for PhD Programme joint supervision will be allowed as per the PhD guideline/ rules of NIT Silchar.
- vi. Karimganj College and NITS shall also explore opportunities for securing funding for joint research projects in response to calls from various National and International organizations / agencies.

GENERAL PROVISION

This MoU shall have an initial duration of FIVE years from the last date of signature, unless either party gives a six-month notice of termination. This MoU may be extended further, in five-year increments, after review and by mutual written agreement.

b) This MoU is a non-binding expression of the current intentions of the Parties, and neither party will incur nor be bound to any legal obligations or expenses hereunder to the other party until and unless definitive agreements have been negotiated and approved by the management levels of each Party.



4. Financial Obligations: There will be no financial obligations on both Parties under this agreement.

5. Intellectual Property: NITS and Karimganj College agree to respect each other's right to intellectual Property. Further, all rights linked to ideas, inventions and patents generated during the MoU, if any, shall remain the common intellectual property of the parties. The parties shall not pass on or give usage rights of such property to any third party without the consent of the other Party. Any such research collaboration to be taken up during due course of time under the ambit of this present MoU shall be legitimized by signing an agreement.

6. Dispute Settlement: Any dispute, controversy, or claim arising out of or in relation to this MoU, including the validity, invalidity, breach or termination thereof, shall be settled by the parties amicably through mutual consultations and negotiations.

7. Liability: Except for loss or damages caused through gross negligence or intent, the Parties shall have no liability to each hereunder.



Nothing in this MoU shall be constructed to create any legal relationship between the Parties. 


