This memorandum of understanding is executed between Purba's Electro World, Station Road, Karimganj

And

Karimganj College, Karimganj, Assam an affiliated College under Assam University, Silchar originally founded as Karimganj College of Arts, Science and Technology in 1946 and provincialised in 2005 by Govt. of Assam in some steps as amended upto date, having its office at Karimganj.

For proper management and disposal of E-waste, a Memorandum of Understanding has been signed between Karimganj College and Purba's Electro World on 22-09-2020 keeping in view the points mentioned below

- 1) The following are the main purposes of the MoU
  - i. To facilitate collection, management and proper disposal of E-waste of Karimganj College.
  - ii. College will collect all E-waste items from all the departments and sections.
  - iii. After collection of the said E-waste, the same will have to be stored in a room.
  - iv. At regular intervals (i.e. yearly once) these E-wastes will be handed over to Purba's Electro World under buy back policy or in exchange of a negotiable amount of money.

2) Validity of MoU

This MoU will remain in force for a period of five years after which it may be extended on yearly basis, if both the parties agree.


