1. PREAMBLE

Established in 1946, Karimganj College is one of the pioneering Colleges of Assam, imparting education in Science, Arts & Commerce. Situated on the bank of Kushiara River demarcating Indo- Bangladesh Border, the College is playing a significant role for last seven decades in the field of Higher Education of the region. Today, it is one of the leading colleges under Assam University. The college has been reaccredited with 'B' grade with CGPA 2.78 in 4.0 point scale by NAAC in the year 2010.

Rabindrasadan Girls' College (RSGC) is one of the leading women-colleges of Assam. Since its inception, the college has been catering to the educational needs of the girl students. The mission of the college is to bring about a Social, Economic, moral and value – based upliftment of the people of various parts of Assam and its neighboring states, especially people of the districts of Karimganj. Initial focus of RSGC was on traditional subjects like English, Bengali, Political Science, Economics, Philosophy, Sanskrit, History in Arts stream but with the expansion of horizons of higher education, Rabindrasadan Girls' College has introduced many other courses that are of contemporary relevance to the stakeholders of the society. The subject computer science was introduced in 2009 in Higher Secondary level and subject Mass Communication was introduced in Arts stream in 2007. Commerce stream was introduced in the college in TDC level in 2010..

Karimganj College and Rabindrasadan Girls' College here in after collectively referred to as institutions and individually as the institute formally agree on a Memorandum of Understanding (MoU) as follows:

The Principal of Karimganj College, Karimganj and the Principal of Rabindrasadan Girls' College (RSGC) for the purpose of furnishing cooperation in education and resource sharing activities between these two institutions, hereby affirm their intent to promote such academic collaborations and to participate in various academic endeavors.

2. OBJECTIVES

This MoU envisages the fulfilling of the following objectives:

- i. To share the resources for mutual academic benefits of both the institutions.
- ii. To create common digital platforms for sharing institutional resources
- iii. To promote research/continuing education/extension activities between the two Colleges .
- iv. Karimganj College and RSGC shall facilitate sharing of their laboratories facilities and library of the Institutions with each other as per mutually agreed terms and condition.
- v. Karimganj College and RSGC shall exchange ideas, students and teachers manpower with a view of enhancing mutually beneficial R&D activities, which would have a bearing on addressing social issues and problems.
- vi. Karimganj College and RSGC shall explore the possibility of conducting joint seminars / workshops/ conferences at National and international levels, in areas of mutual interest.

3. GENERAL PROVISION

a) This MoU shall have an initial duration of THREE years from the last date of signature, unless either party gives a six-month notice of termination. This MoU may be extended further, In Three-year increments, after review and by mutual written agreement.

b) This MoU is a non-binding expression of the current intentions of the Parties, and neither party will incur nor be bound to any legal obligations or expenses hereunder to the other party until and unless definitive agreements have been negotiated and approved by the managements levels of each Party.

4. Financial Obligations: There will be no financial obligations on both Parties under this agreement.

5. Intellectual Property: Karimganj College and Rabindrasadan Girls' College agree to respect each other's right to intellectual Property. Further, all rights linked to ideas, inventions and patents generated during the MoU, if any, shall remain the common intellectual property of the parties. The parties shall not pass on or give usage rights of such property to any third party without the consent of the other Party.

6. Dispute Settlement: Any dispute, controversy, or claim arising out of or in relation to this MoU, including the validity, invalidity, breach or termination thereof, shall be settled by the parties amicably through mutual consultations and negotiations.

7. Liability:

i.. Both Parties agreed to help, identify and invite the faculty members and subject experts to participate in conferences, workshops, seminars and training sessions.

ii. Karimganj College and RSGC must make available their resources for each other as per rules and regulations.

iii. If any document will be taken for lending purpose under resource sharing initiative then the borrower authority will be responsible to make necessary charges and payments in case of loss or damage.

iv. The college librarians or faculty members entrusted by the College authority will be responsible to act as nodal persons for operation of the resource sharing for libraries.

8. Legal Relationship: This MoU shall be construed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the parties. Nothing in this MoU shall be constructed to create any legal relationship between the Parties. Details of specific cooperation will be determined on a case- by- case basis and by mutual agreement consistent with this memorandum of understanding. (MoU)
